

In order to transfer your artificially derived CBN to OLCC licensees, you will need to work with a hemp handler licensed by the Oregon Department of Agriculture who holds a hemp certificate with OLCC. After receiving the material into their Oregon facility, this handler will be able to enter it into the Cannabis Tracking System and request the compliance testing required by OAR 845-025-2755 and 845-025-5800 to 845-025-5850.

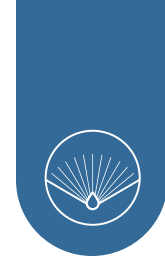
